1 Product Summary

Ancon BT Type A and Type C couplers in the size range 16mm - 40mm are for the mechanical connection of deformed high-yield carbon steel bars for the reinforcement of concrete complying with the requirements of BS4449 Grade B500C.


1.1 Scope of Application

Ancon BT Type A and Type C couplers in the size range 16mm - 40mm have been evaluated for use as follows:

 a) TA1-B: Eurocode 2 and BS 8110 for static applications in tension only with BS4449 Grade B500C reinforcement.

1.2 Design Considerations

BS 8110 Clause 3.12.8.9 Laps and Joints states "Connections transferring stress may be lapped, welded or joined with mechanical devices. They should be placed, if possible, away from points of high stress and should preferably be staggered". However, BS 8110 Clause 3.12.8.16.2 Bars in tension states "The only acceptable form of full-strength butt joint for a bar in tension comprises a mechanical coupler" satisfying specified slip and tensile strength criteria.



Eurocode 2, Clause 8.7 Laps and mechanical couplers 8.7.1 General (1)P "Forces are transmitted from one bar to another by:

- · lapping of bars, with or without bends or hooks;
- welding:
- mechanical devices assuring load transfer in tension-compression or in compression only."

Clause 8.8 Additional rules for large diameter bars goes on to state that "Splitting forces are higher and dowel action is greater with the use of large diameter bars. Such bars should be anchored with mechanical devices."

The specified cover for fire resistance and durability should be provided to the coupler sleeve. All couplers have been designed with controlled mechanical properties to be compatible with reinforcing bars complying with reinforcement of the relevant Grade in accordance with BS4449.

1.3 Conclusion

It is the opinion of CARES that Ancon BT Type A and C Couplers in the size range 16mm to 40mm are satisfactory for use within the limits stated in paragraph 1.1 when applied and used in accordance with the manufacturer's instructions and the requirements of this certificate.

2 Technical Specification

2.1 General

The function of Ancon BT Types A and C Couplers are to connect deformed steel reinforcing bars complying with BS 4449 Grade B500C as appropriate and thereby create structural continuity of the reinforcing system.


BT couplers offer a full strength connection. Each end of the bar to be joined is cut square and enlarged using a cold forging process. A special thread form is then rolled onto the enlarged bar end. The thread form is such that the cross sectional area of the bar ends is not reduced, thus ensuring the strength of the connection matches or exceeds that of the parent bars.

Each thread rolled bar end is proof loaded to force equal to the characteristic yield strength of the rebar.

2.2 BT Type A Standard Couplers

The Ancon BT parallel thread couplers are an internally threaded steel sleeve. A special parallel thread form is cold rolled onto the ends of the bars being connected. The Type A standard coupler is suitable for applications where the continuation bar can be rotated.



2.3 BT Type C Positional Couplers

The Ancon BT parallel thread couplers are an internally threaded steel sleeve. A special parallel thread form is cold rolled onto the ends of the bars being connected. The Type C coupler is suitable for applications where the continuation bar cannot be rotated.

3 Product Performance and Characteristics


Mechanical tests have been carried out to demonstrate compliance with the performance requirements defined in CARES Appendix TA1-B when used with reinforcing steel BS4449 Grade B500C as appropriate:

CARES APPENDIX TA1-B requirements


- Permanent deformation is less than 0.10mm after loading to $0.65f_{\rm y}$ in tension with BS4449 grade B500C reinforcement.
- 99% characteristic tensile strength is greater than 575MPa with B500C reinforcement.

4 Installation


BT Type A Standard Couplers



Screw the coupler to the rear of the thread on the fixed bar and lock tight. The bar end should be central within the length of the coupler. Remove the plastic cap from the coupler.



Position and rotate the continuation bar in the coupler.




Tighten the joint using a wrench on the continuation bar. After tightening there should be no more than 2 - 4mm of thread exposed, depending on the diameter of the rebar.








BT Type C Positional Couplers



Screw the locknut followed by the coupler to the rear of the thread on the continuation bar.



Position the continuation bar with the coupler against the end of the first bar.



Rotate the coupler from the continuation bar to engage against the rear of the thread on the opposing bar and lock tight.



Hold the rebar in the required orientation and with a wrench tighten the locknut against the coupler.

5 Safety Considerations

Ancon BT couplers are generally supplied in robust cardboard cartons. Containers weighing up to 25kg may be handled with care. Heavier cases require the use of mechanical handling equipment. Protective gloves should be work when installing the couplers.

6 Product Testing and Evaluation

Ancon BT Type A Standard and Type C Positional Couplers have been tested to satisfy the requirements of CARES Appendix TA1-B for Couplers with reinforcing bars to BS4449 Grade B500B or C as appropriate. The testing comprised the following elements:

- · Tensile Strength
- · Permanent deformation in tension

7 Quality Assurance

Ancon BT Type A and Type C Couplers are produced under an EN ISO 9001 quality management system certified by CARES. The quality management system scheme monitors the production of the couplers and ensures that materials and geometry remain within the limits of this technical approval.

The products are also subject to a programme of periodic testing.
